# 1st Freiburg Phd-Workshop on the Economics of Criminal Behavior



#### **Background**

The 1<sup>st</sup> Freiburg PhD-Workshop on the Economics of Criminal Behavior took place September 30 to October 2, 2024. It offered unique opportunities for early career researchers to connect with leading experts, engage in lively discussions surrounding the topics of criminal behavior and crime prevention from innovative perspectives, and to present own ideas and projects for constructive feedback. The timing of the workshop directly connected it to the 2024 Transatlantic Workshop on the Economics of Crime ('TWEC') at ETH Zurich.

Day 1: welcome, PhD presentations, MAXLab tour, joint dinner

Day 2: course I, lunch, PhD presentations, keynote I, free evening

Day 3: course II, lunch, PhD presentations, keynote II, joint dinner

The student presentations showcased the variety of topics studied and methods used in current Economics of Crime, ranging from tax evasion to prison research and applied microeconomics to RCTs.

The compact course spanned from the beginnings of the Economics of Crime literature to current NBER papers, emphasizing emerging methods and topics in the field.

Out keynote speakers Anna Bindler and Christian Traxler gave comprehensive overviews of their work on victimization and deterrence.
